



Rent Received in Advance

Property Management Solutions for Over 30 Years

Overview

This document explains options for posting rent money received in advance.

When rent is received in advance there are two options available. The first — Advance Payment — causes the entire amount paid to be credited immediately to the owner's ledger. The second — Open Credits — retains the money in the tenant's account and gives it to the owner as charges are posted.

Option 1 - Advance Payment

1. Go to <<AR, Tenant Receipt>>
2. Select the [Tenant]
3. Enter the payment [Amount]
4. Click on the New Charges tab
5. Select the [Charge] (e.g. Rent) from the drop down list
6. Enter the [Amount] being applied to the charge
7. Click on the [Advance Payment] checkbox so it is marked
8. Review the entries for accuracy
9. Click <New> or <Post>

Option 2 - Open Credits

Open credits are available funds that have not been designated toward charges. They are given to the owner as charges are posted when the charge is less than or equal to the credit amount. Payments received (or parts thereof) that you do not want to give to the owner immediately can be held back and given to the owner as charges are posted. See [Document #217 Apply Open Credits](#).

1. Go to <<AR, Tenant Receipt>>
2. Select the [Tenant]
3. Enter the payment [Amount]
4. Allocate the payment amount as appropriate. Whatever amount is left unallocated will be applied to open credits
5. Review the entries for accuracy
6. Click <New> or <Post>
7. A message will display alerting you to the amount being applied to open credits. Click <OK>

Advance Rent Held in Escrow

If your tenant pays rent in advance and you want to hold the money in the Escrow bank instead of the Checking bank, follow the procedure below.

One Time

Set up an account code and charge code

1. Go to <<Setup, Charge Codes>>
2. Click the <New> button
3. Type in an ID of AdvRentDep
4. Type in a long description of Advance Rent Deposit
5. Click on the flashlight button for [Account]
6. Type in an ID of AdvRentDep
7. Type in a long description of Advance Rent Deposit
8. Type in a [Ledger code], e.g.9999
9. Select an [Account Type] of Current Liability
10. Mark the checkbox for Escrow Deposit Analysis
11. Click <Save> to go back to the Charge Code screen.
12. Mark the checkbox [Use to Track Deposits]
13. Click <Save>

Each Time

1. Go to <<AR, Charge Tenant>>. Charge the amount of the whole payment from the tenant.
2. Go to <<AR, Tenant Receipt>>. Pay off the Advance Rent Deposit charge and receive the money into the Escrow bank.

To use the money to pay off charges you will have to follow the [Security Deposit Refund](#) procedure to release the deposit into Open Credits.
